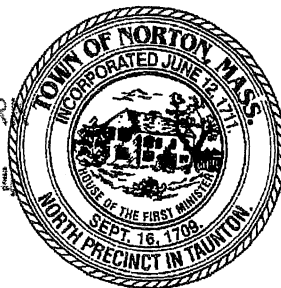

Call to order: Ms Battistello, Vice-Chairman called the meeting to order at 5:00 PM.

A Motion was made by Mr. Medeiros to acceptance the minutes from the March 6, 2023 meeting, Ms. Battistello 2nd

Vote 2-0 approved

Old Business: Chris Zahner, Health Agent gave an update on the following: 32 N Worcester St, he will be doing a visit to the site to check up on the progress made in regards to the cleaning up. The health agent told the board that 71 Richardson Ave and 71 North Worcester St have both had their condemnations lifted. The Health Department ran a Hazardous Waste Day on May 13, 2023 and it was a big success.

New Business:

Red Mill Village has requested a variance that requested approval to test their pool 2x a day. The Town of Norton's regulations require the pool is tested 4x a day. After a discussion, Robert Medeiros made a motion not to approve the variance. Ms Battistello 2nd.

0 South Worcester St septic design plans were sent to Hermeneau & Hermeneau Consulting for Peer review. MBL Land Development paid \$10,000 to the Town of Norton, for the consulting fee. The actual cost for the consulting was \$6100. Therefore, MBL Land development is owed a refund of \$4750.

Mr. Medeiros made a motion to release the funds of \$4750 back to MBL Land Development. Ms. Battistello 2nd.

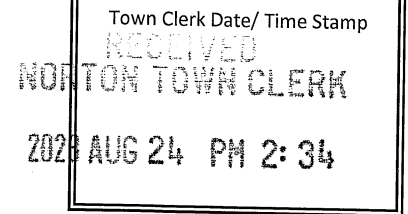
