Before being fingerprinted, all licensing applicants are required to present government-issued identification for verification. A licensing applicant's fingerprints will not be collected until his/her identity has been verified. The following forms of identification will be accepted:

- Driver's License
- Passport
- Massachusetts Registry of Motor Vehicles Identification Card

### FEES

Fingerprinting fees include federal, state and local fees. Before being fingerprinted, all licensing applicants must pay the statutory fingerprint fee of thirty dollars (\$30.00) with a money order or bank check payable to the "Commonwealth of Massachusetts." In addition to a signature, the money order or bank check shall include the name of the applicant hand-printed in block letters.

In addition, licensing applicants must pay the municipal fingerprint fee of seventy dollars (\$70.00) with a money order or bank check payable to the "Town of Norton." In addition to a signature the money order or bank check shall include the name of the applicant hand-printed in block letters.
